BACKGROUND

- SKILLS TO DETECT, PROSECUTE, AND PUNISH FISHERIES CRIMES
- INTER-AGENCY COLLABORATION ALONG THE ENFORCEMENT CHAIN (NATIONAL AND INTERNATIONAL LEVEL)
- EXISTING TRAINING PROGRAMS (LESSONS LEARNT):
 - ✓ CURRICULUMS: RELEVANT, REGULARLY UPDATED, BASED ON CAREFUL NEEDS ASSESSMENTS FOR EACH SET OF TRAINEES
 - ✓ TRAINING METHODS FOR OPTIMAL LEARNING EXPERIENCE
 - ✓ AVAILABILITY OF RESOURCES TO ENSURE CONTINUITY OF LEARNING PROCESS
 - ✓ REGIONAL APPROACH FOR GREATER IMPACTS IN THE GLOBAL FIGHT AGAINST FISHERIES CRIME

ESTABLISHMENT OF THE IFFAI AND TRAINING PROGRAMS

- MOU BETWEEN THE MINISTRY OF MARINE AFFAIRS AND FISHERIES, THE NATIONAL POLICE, AND THE PRESIDENTIAL TASK FORCE TO COMBAT ILLEGAL FISHING ON DECEMBER 3RD, 2016
- REGIONAL CENTER OF CAPACITY BUILDING AGAINST FISHERIES CRIME FOR ASEAN AND SOUTH PACIFIC COUNTRIES
- 1st IFFAI TRAINING: 16-25 MARCH 2017 (SEMARANG, JAKARTA CENTER FOR LAW ENFORCEMENT COOPERATION)



IFFAI TRAINING PROGRAM: KEY FEATURES

- **INTER-AGENCY COLLABORATION FOR EFFECTIVE ENFORCEMENT**

- TRAINEES FROM MULTI-AGENCIES ALONG THE ENFORCEMENT CHAIN AGAINST FISHERIES CRIME
- PROVIDING A CLEARER VISION ON THE OVERALL ENFORCEMENT SYSTEM, AND HOW THEY CAN COLLABORATE WITH OTHER AGENCIES ACCORDING TO THEIR OWN MANDATES
- RAISING THE AWARENESS: EFFORTS OF ONE AGENCY WOULD BOLSTER THE EFFORTS OF OTHER AGENCIES IN HANDLING FISHERIES CRIME CASES



IFFAI TRAINING PROGRAM: KEY FEATURES

- **APPLICATION OF MULTI-LEGAL REGIME AND CORPORATE CRIMINAL LIABILITY APPROACHES**
 - AWARENESS THAT FISHERIES CRIME IS A CROSS-SECTOR CRIME
 - HOW TO EFFECTIVELY APPLY THE MULTI-DOOR APPROACH, BY UTILIZING VARIOUS LEGAL REGIMES BESIDE THE FISHERIES LAW
 - SUCCESSFUL PROSECUTIONS AGAINST THE MASTERMINDS BEHIND THE CRIME AND RECOVERY OF CRIME PROCEEDS



IFFAI TRAINING PROGRAM: KEY FEATURES

- **EXPERIENTIAL LEARNING**

- LEARNER CENTERED, ACTIVITY ORIENTED, FORMULATION OF ACTION PLANS, TECHNOLOGY-ASSISTED LEARNING
- CASE SIMULATIONS TAILORED BASED ON REAL CASES
- GROUP OF TRAINEES CONSISTING REPRESENTATIVES FROM EACH AGENCIES (EXCHANGE OF VIEWS BETWEEN TRAINEES FROM DIFFERENT ENFORCEMENT AGENCIES, BUILDING COMMON PERCEPTION AND BETTER COLLABORATION)
- PRACTICAL EXERCISES ON CASE-HANDLING AND INTER-AGENCY COLLABORATION



WAY FORWARD

- COOPERATION WITH THE INTERNATIONAL FISHERIES CRIME EXPERT PANEL (EXPERT RESOURCES, CURRICULUM DEVELOPMENT, DATABASE ON FISHERIES CRIME CASES)
- INTER-CALIBRATION BETWEEN THE INTERNATIONAL FISHFORCE ACADEMY IN EVERY REGION (SOUTH AFRICA, INDONESIA, AND POSSIBLY OTHER REGIONS) TO SET STANDARDIZATION FOR THE INTERNATIONAL FISHFORCE ACADEMY TRAINING PROGRAMS
